In accordance to the judgment dated 28.10.2020 passed by the Hon'ble Supreme Court in Special Leave Petition Diary No. 22811 of 2020 read with the judgment of the Hon'ble High Court at Calcutta in WPA No. 5890 of 2020 dated October 13, 2020, particularly with regards to Para 61 (ii) to (iii) and (xvii) to (xxii) of the said order and without prejudice to any rights of the School to challenge directions passed by the Hon'ble High Court the parents/guardians are intimated as follows:

- 1) The Hon'ble Supreme Court in Special Leave Petition bearing Diary No. 22811 of 2020 vide its order dated 28.10.2020, was pleased to grant stay to the operation of directions (viii) to (xvi) in Para 61 of the order passed by the Hon'ble High Court of Calcutta in WPA No. 5890 of 2020 in the meantime.
- 2) The school along with other Petitioners has already filed Special leave Petition (Diary) No. 23545 of 2020, which is likely to be listed before the Hon'ble Supreme Court on 02.11.2020, challenging the directions passed by the Hon'ble Division bench of Calcutta High Court whereby in addition to the stay already granted by the Hon'ble Supreme Court, the school alongwith other schools as Petitioners will be praying for further reliefs including stay of the rest of the directions which were passed by the Hon'ble High Court on 13.10.2020.
- 3) It is to be noted that till the Special Leave Petition filed by the schools is placed before the Hon'ble Supreme Court, without prejudice to the rights of the school to challenge the said directions and in compliance with direction no. (ii) and (xvii) enumerated in Para 61 and seek any

(ii) and (xvii) enumerated in Para 61 and seek any further clarifications to the order dated 13.10.2020 passed by the Hon'ble High Court, it is indicated that the parents and guardians of the students shall have the option to pay the fees as per the fee schedule appended as **Annexure-1** to the present notice.

- 4) However, in accordance to the direction (vii) of the Hon'ble High Court in its judgment dated 13.10.2020 in WPA No. 5890 of 2020, the parents who are in a position to pay the entire amount of fees (100%) without undue hardship, are requested to pay the fees in terms of fee schedule appended as **Annexure-2** to the present notice.
- 5) In cases where the parents have already paid 100% of the fees but wish to avail of the concession in fees and pay in accordance with the fee schedule appended at **Annexure-1**, the school will not be in the position to refund the said amount. However, the amount paid in excess of 80% of the fees shall be adjusted against the fees payable for the period commencing subsequent to 30.11.2020.
- 6) The tuition fees, as payable for the period upto 30.11.2020, is required to be tendered by **30.11.2020**.
- 7) The present notice shall also vest no right in any person to claim a reduction in fees beyond the terms of the judgment dated 13.10.2020 of the Hon'ble High Court of Calcutta in WPA No. 5890 of 2020, and subject to such orders as may be passed by the Hon'ble Supreme Court in any appeal preferred against the said order.

- 9) It is a humble appeal to all parents/ guardians to kindly support the school in these unprecedented difficult times to the best of your financial capabilities as the school being an unaided school is undergoing extreme financial crunch, with great difficulty is trying to make ends meet with regards to basic subsistence, maintenance and to support all our beloved teachers, staff members as well as the students belonging to the underprivileged section of the society, who are most hit by the present pandemic.
- 10) That due to the complete restructuring of the fees schedule in furtherance to the order dated 13.10.2020 passed by the Hon'ble High Court and the concessions that were already provided on account of letter dated 20.07.2020 issued by the Principal Secretary, Department of School Education, in conjunction with the uncertainty with regards to re opening of schools in the physical mode, the school requires some
