It is hereby notified, the Hon'ble High Court of Calcutta in WPA (P) No. 162 of 2021, vide order dated 02.07.2021 has directed the school (along with all other schools and teaching institutions in West Bengal), to file a list of students who have defaulted in the payment of school fees before 06th August 2021.

In compliance with the aforesaid order, the school will be preparing and finalising a list of defaulters on 01st August 2021. All parents are requested to clear their pending fees due on or before 25th July 2021, to avoid appearance of their name in the list of defaulters that would be submitted before the Hon'ble High Court of Calcutta.

It is further re-iterated for the sake of clarity that the present notice is without prejudice to the rights and legal remedies available to the school in relation to WPA (P) No. 162 of 2021 pending before the Hon'ble High Court of Calcutta and the same is subject to such orders as may be passed by the Hon'ble High Court of Calcutta in any appeal preferred against the said orders.

The school further reassures that as the judgment and order dated 13.10.2020 passed by the Hon'ble High Court is presently under challenge and the Special Leave Petition (Civil) No. 13006 of 2020 is subjudice before the Hon'ble Supreme Court, without prejudice to the pending Special Leave
