NOTICE

(Regarding fees for the students of Classes KG to VIII, Academic Session 2020-21)

In furtherance, to the compliance with the directions passed by the Hon'ble High Court at Calcutta vide judgment dated October 13, 2020, in WPA No. 5890 of 2020, particularly with regards to **Para 61 (vii), (xvii), (xviii) and (xix)** of the said order, read with the order dated 28.10.2020 passed of the Hon'ble Supreme Court in Special Leave Petitions (Civil) No.12951 of 2020, and the notice dated 31.10.2020 along with clarification as per direction no. (xvii),(xviii) and (xix), without prejudice to any rights of the School to challenge directions passed by the Hon'ble High Court the parents/guardians are intimated as follows:

- 1) The school has filed SLP No. 13833 of 2020, before the Hon'ble Supreme Court along with other Petitioners and the same was listed for hearing on four (04) occasions, most recent being on 23.02.2021, however due to paucity of time and in the interest of justice, the Hon'ble Supreme Court has listed all the SLP's for final hearing in the first week of April 2021.
- In the meanwhile, as most of the offices, businesses and sectors have returned to back to normalcy thereby carrying out their financial activities as earlier, the parents/ guardians, who are in the position to pay the entire amount of fees (100%), are requested to pay the fees in terms of **Annexure-II** in accordance to **direction no. (vii)** of the High Court's order.
- The parents/ guardians of all students studying in Class KG to VIII are hereby requested to clear all dues of school fees, as payable either as per <u>Annexure I</u> or <u>Annexure II</u> published as per <u>direction no. (xvii)</u> upto the period of March 2021, latest by 20.03.2021.
